<sup>4</sup> Included are stocks of all other oils such as aviation gasoline, kerosene, natural gas liquids and LRG's (except propane/propylene), other hydrocarbons and oxygenates, aviation gasoline blending components, naphtha and other oils for petrochemical feedstock use, special naphthas, lube oils, waxes, coke, asphalt, naphtha-type jet fuel, road oil, and miscellaneous oils.
